5 Mobil Corporation. Signed: Susan Robinson, Presiding Juror, Dated: 2-8-08."



**NATURE OF PROCEEDINGS:**

MOTION OF DEFENDANT (PACIFIC TECHNICAL SERVICES) FOR AN ORDER:

1. TO DETERMINE THAT PACIFIC TECHNICAL SERVICES IS THE PREVAILING PARTY HEREIN;
2. TO RECOVER COSTS AND ATTORNEY'S FEES AS AN ITEM OF COSTS;

Matter is called for hearing and is argued.

There being no dispute that Pacific Technical Services is the prevailing party in this action, the Court makes the following order with respect to the claim of defendant for costs and attorney fees:

The following items of the cost bill, "Memorandum of Costs," claimed by Pacific Technical Services, are orderd stricken: Items 9 and 10.

The following items are ordered reduced:

- Item 1, from \$4,785.75 to \$4,504.85
- Item 4, from \$37,221.35 to \$36,246.35

The remaining items on the cost bill are allowed.

Total costs are allowed in the sum of \$67,924.46, and entered on the judgment by the Court.
